



《旅游资助计划》条规

1.0 必备条件

- 1.1 《旅游资助计划》仅供年龄 12 岁或以上的马来西亚公民参与。
- 1.2 报名者需活跃于社交网站如面子书，推特等。
- 1.3 若报名者拥有活跃的部落格将加强被本社接纳的机会。

2.0 配套

- 2.1 《旅游资助计划》仅限于本社组织的任何旅游配套。
- 2.2 如报名者有任何要求，可向本社提出，但最终决定将取决于本社。
- 2.3 报名者需填妥报名表，连同照片一张交予本社。

3.0 旅游保险/签证

- 3.1 本社强烈建议报名者购买一份旅游保险（自费），及自理签证。

4.0 责任

4.1 旅客若发生下列事故，当由旅客自行负责，一概与本社 / 授权代理无关。这些事故包括：

- e) 报名者如要更改航线或日期，则需自行承担一切的风险。本社将不负任何责任事故而造成的不便和所产生的额外费用。

1.0) Obligatory

- The (Travel Subsidy Scheme) is only applicable to Malaysian Citizens, aged 12 years and above only.

2.0) Package

 5. Applicants who wish to change the itinerary or date, will bear all risk or consequences that may arise. The agency will NOT be responsible of any accident caused by the inconvenience and arising additional costs.
 6. Passengers who bring any prohibited items, faulty travel documents, misbehave or engage in activities that are considered illegal and harmful to the discretion of the travelling country governments, and have been refused entry or expelled by immigration offices.

5.0) Subvention

- Subsidies to applicants will be provided upon receipt of the manuscript and the photos (in order), in the means of cash, or

6.0) Subsidy
